No Subscription increases in 2010

First, I must announce there will be NO CHANGE IN SUBSCRIPTION PRICES in the near future. There was a great deal of discussion about the future of the Connecticut Granger at the recent State Session due, in part, to a resolution calling for a \$10 subscription price. All of us at the Granger were under the impression we were coming very close to going beyond interest income to cover the increased cost of producing and mailing the paper. As a result, a change was adopted by the board of the Granger calling for \$5.00 for non-100% Granges and \$4.00 for 100% Granges.

After State Session, State Treasurer Phil Bergquist examined the investment accounts of the Connecticut Granger Trust Fund and found that while our interest income is down more than \$10,000 this year and our expenses are up slightly, we are not in danger of using principal to cover our expenses.

Part of the problem is State Grange financial statements that are confusing and misleading. The day to day finances of the Connecticut Granger are handled by Granger Secretary/Treasurer Edith Schoell. The Trust Fund accounts are handled by the State Grange and Treasurer Phil Bergquist. I have asked Brother Phil to prepare a consolidated financial statement at the close ... continued on page 2

towns in Connecticut held their municipal elections November 3 and the newly elected officials will soon be sworn into office. Many of these officials will not receive any pay for their work and others will receive a small sum of money that is more of an honorarium than anything approaching reasonable compensation fortheir

time. Some of the newly elected officials see their new positions as stepping stones to higher offices in the future, but for now they are volunteering their time for the good of their town. Certainly there will be differences of opinion as to what is best for each town and there will be situations where everyone agrees on what should be done, but there will be differences of opinion as to which are the higher priorities and how much the town can afford to do in any one year. Still, everyone is interested in improving their town. Much time and expertise in many different fields will be needed to research the various problems the towns will face in the

coming year. The Board of Selectmen or the Town Council cannot do it all by themselves. They will need the help of volunteers to and commissions that will address in detail the issues their towns are facing. The immediate question facing most Boards of Selectman and Town Councils is who will be willing to fill the many vacancies on the boards and commissions in their town. There are similarities here to our Granges at all levels.

Then, when something good has been accomplished in your town, take pride in saying, "I helped get that project done."



Don't wait until the last minute. Now is the time to start thinking about next years contests. Your Lecturer will have a complete list by Nov. 1st.


It was nice seeing so many of you at State Session. By the time you read this, we will probably be on our way to National, but when we get back I hope to see you around the State.



Poor Dairy Farmers

- When I say Poor Dairy
Farmers, I mean they are
producing milk at a cost of

producing milk at a cost of \$3.50 per gallon, and they are being paid \$1.00 per gallon. I saw a lady at the State Capitolon Agriculture Day in March who told me they lost \$10,000 in the month of February. They milk around 1,100 cows. I receive the Lancaster Farming paper, and they told of a meeting in Garclonville, PA where farmers were looking for answers. They expected about one hundred people, and it turned out to be around five hundred.

A lady farmer at this meeting that had bills of \$50,000 because her son was in the hospital and she had a milk check of \$15,000. There was a federal order passed in 1930 or 1931 to help farmers get a fair price for milk, but this order did

not do anything for the farmers because dealers could do anything they wanted with the price.

Gordon Gibson spoke a while ago of milk from California. This milk would be a week old before we would get it. I saw a farm in Idaho that had 14,000 cows and I heard of a farm in California that had 30,000 cows. There is no way that could be done here. Their biggest problem was getting rid of the manure. The thing I do not know is if all the milk is used for something and with the increase of population, why we have the problem.

The next time you buy milk, remember the dairy farmer.





Resolutions Adopted at the 125th Session of the Conn. State Grange

The following resolutions were adopted at the 125th Session of the Connecticut State Grange. Resolutions that were printed in the last issue are only printed with their resolves in this issue. New resolutions/committee resolutions adopted at the session are printed in their entirety. The complete list of resolutions adopted and rejected are available on the website at www. ctstategrange.org.

1) RE: CONNECTICUT'S STATE CAKE

THEREFORE BE IT RESOLVED that the Connecticut State Grange urge that the Election Cake, this piece of Americana, be placed on the list of Connecticut's symbols, and

THEREFORE BE IT FURTHER RESOLVED that the Connecticut State Grange Legislative Committee submit this resolution to the State Legislature for their consideration, and

BE IT FURTHER RESOLVED that Grangers in Connecticut be urged to get behind this effort following the guidance of the State Legislative Committee.

NATIONAL PARK RE: SERVICE FUNDING

THEREFORE BE IT RESOLVED that the National Grange encourage Congress to appropriate the necessary funds or to establish a funding plan or program to meet the estimated \$400 million necessary to repair and properly maintain the National Mall.

4) RE: HIGHWAY ON/OFF RAMP SAFETY

WHEREAS many of these elderly mailing addresses are given or sold by organizations they belong to without their permission.

THEREFORE BE IT RESOLVED that the Connecticut State Grange work with our legislators to develop a "DO NOT MAIL LIST" program by developing a form to be returned to the mailer, using their envelope and literature, requesting the person's name be removed from the mailing list which would allow the elderly to deal directly with the junk mail originator and allows elderly to receive those wanted mailings, and

BE IT FURTHER RESOLVED that this resolution go on to the National Grange for their support on a national "Do Not Mail List" program, and

BE IT FINALLY RESOLVED that if this program works for our elderly that it be expanded to everyone.

36) RE: OVERSIGHT OF FARM **PRODUCTS**

WHEREAS the Farm Safety Act, H.R. 2749 has been passed by the House of Representatives and is in committee at the Senate, and

WHEREAS this bill deals with food safety for food delivered from the producer to the customer, and

WHEREAS this bill has both good and undesirable issues for both the large farms and small farms, and WHEREAS the good points deal with

the large industrialized farms and the food coming from other countries and whose facilities have the manpower for the necessary record keeping, and WHEREAS the undesirable issues concern mostly the smaller local farmer in that unannounced inspections and considerable record keeping are involved and he/she does not have the time, the money or the facilities needed, and

WHEREAS the regulations to implement this resolution have not been clearly defined, and

WHEREAS Representative Rosa DeLauro is coordinating with the Connecticut State Grange a similar resolution, and

WHEREAS the attending members of the Northeast Legislative & Agriculture Committees voted in the affirmative to oppose the Food Safety Act H.R. 2749 on September 27, 2009.

THEREFORE BE IT RESOLVED that the policy of the Grange be that all food products on the farm, at farm stands, and farmer's markets, be under the sole oversight of the United States Department of Agriculture.

BE IT FINALLY RESOLVED that this resolution be forwarded to the National Grange together with a recommendation for appropriate action therein.



As we look forward to this season of giving thanks for all our many blessings let us fill our lives with humility. Humility is one of the most puzzling parts of our spiritual journey. Most of the founders of the values we hold close lived humble lives and invited us to experience the power and wonder of this life.

Today we are in awe of those with the courage to live their lives this way and few of us attempt to follow their example. Humility, we think is weak.

Humility is a mystery for most of us. God has great humility toward man. I had never thought of God as being humble, but if we are made in God's image and are called to humility, it makes sense that God would be the author of humility. However the idea of God being humble toward us revealed once again the mystery of the spiritual journey.

The truth is that God is humble toward us, for we are allowed to live our lives according to our values and desires. Free will is a great gift from Spirit, and it is an example of the humble God. However, I can seek the kingdom and enter into the mystery of life and allow an awareness of Spirit to establish itself, not only as an experience but as my life. This is my humility toward God and when it is joined with God's humility, I am humbled once more by the wonder of what life can
