



The Connecticut Working Lands Alliance is now a project of American Farmland Trust and Jiff has been the Connecticut coordinator for all the AFT activities in Connecticut. The Working Lands Alliance is recruiting for a new project director to replace Ms. Martin.

The president of Connecticut Farmland Trust stepping down after three years and becoming a member at large on the executive committee is as customary as the Master of the Connecticut State Grange stepping down after four years and being elected to the Executive Committee. The CFTGovernance Committee, which also serves as the nominating seeking committee, isvolunteers to fill one or two anticipated vacancies on the Board of Directors at the trust's annual meeting Directors in February. are elected for three year terms. They are expected to attend the bimonthly board meetings and also serve on one or two of the trust's committees. concerning individual. Although the names are very similar, Connecticut Farmland Trust has no connection with American Farmland Trust. Connecticut Farmland Trust acquires holdsand easements preserve farmland throughout Connecticut while American Farmland Trust lobbies for legislation to protect farms and keep farm operations viable at both the state and federal level.

As some of you already know, I am stepping down as Legislative Director for the Connecticut State Grange at our annual session this month. As a member of the State Grange Executive Committee I will continue to be an ex-officio member of the Legislative Committee and the present plan is that I will continue to lobby for our issues at the General Assembly. I am completing twenty years on the Legislative Committee and twelve years as Legislative Director. Degrees and their meanings



My last article was from Rev. Aaron B. Grosh's thoughts on the degrees, written in 1876. There will be several articles over the next few months covering the Seven Degrees.

Degrees and Their Meanings First Degree

The Emblem of Laborer, in this degree, is an evenly balanced pair of Scales, a nest of just weights, and a heaped (or full) measure as may be required by custom or law, to denote HONESTY..."

"The emblem of a Maid in our Order is the Spindle or Distaff, with the motto (or reference). 'Proverbs



the emblem is a reminder, that we refer the reader to its admirable description of female life and character..."

"Another emblem of this degree is given in the Ritual and another, combined with it here, is used in conferring the degree, the Bouquet of dried grasses, which we have placed in the Wreath (or crown) of grasses. The Bouquet denotes HUMILITY..."

Second Degree

"The Emblem of the Cultivator in this degree is a Vine, and a Tree to be planted-- the vine already set, and the ground open to receive the tree. They are designed to remind him of an important injunction given at his promotion, and having reference to a much desired result. And they are further to teach the great lesson, that we are placed here, not only to be ministered unto in the orchards, forests, and improvements of the land and the people, or in the institutions and advantages of the minister unto others around us, and who may come after us. Honesty to mankind, no less than gratitude to the Giver of all good, requires that we hand down to posterity what we have received from others, with added interest on that capital, in the shape of improvements of our own devising and making..."

"The Emblem of Shepherdess, in this degree, is the Shepherd's Crook and Shepherd's Pipe; The Crook denoting the employment of directing, protecting and correcting her flock; and the reed, or pipe, indicating their recreation and pleasure by its musical strains. The lambs, and the flowers amid which they are reposing, speak of the beauty and innocence of childhood (her peculiar care), and the enjoyments to be shared with them in their instruction, and in promoting their pleasures. And all this has reference to the pastoral life, merely as an emblem of the real, actual life of woman in society at the present period. While the world of society has outgrown the rude and simple times of ignorance which characterized the ancient days, when noble women and princesses tended flocks, and spun and knitted their wool, we would retain for woman, in her present sphere of life and duty, all the simplicity, the purity, the kindliness and pleasures, of the pastoral ages...

"Another emblem of this degree, for the Shepherdess, is the Altar, surmounted with an open Bible, covered with Roses, denoting religious worship and instruction, and delight in the same."





2010 State Session Resolutions

The following resolutions were available at press time. Additional resolutions may be added to the Session Booklets later. For the first time committee assignments are listed with the resolutions giving delegates the opportunity to study the resolutions and do any research prior to arriving at Session. All information provided below is subject to change.

RE: LOWERING AGE OF BLOOD DONORS

WHEREAS volunteer blood donations are the basis of the nation's blood supply, and

WHEREAS blood collection facilities have placed greater emphasis on donations from younger donors as donations from older donors are declining due to individual health issues and other eligibility

WHEREAS reports from blood collection facilities indicate that 10 to 20 percent of all whole blood collections in the United States now come from blood donors who are less than 20 years old, and

WHEREAS these young people are also ideal donors because they have lower deferral rates and by experiencing donation early in life, they are more likely to continue donating in the future, and

WHEREAS twenty-two states now currently allow 16 year olds to donate blood with parental consent.

THEREFORE BE IT RESOLVED that the CT State Grange urge the passage of legislation allowing 16 year olds who meet the weight and health requirements to become blood donors with written parental

BE IT FURTHER RESOLVED that no minor would receive monetary payment for the blood donation.

20. RE: APO & FPO ADDRESSES

WHEREAS when a package is mailed to someone in the Military and they are serving overseas the package is mailed to an Army Post Office (APO) or Fleet Post Office (FPO). A typical address would look like: Top line is the Soldier's name, next line is their unit number, and the last line may look like APO AE 09xxx or 96xxx. The last 5 numbers are the zip code with 09 being in New York and 96 is California, and

WHEREAS when a package is shipped from a local East coast Post Office to an APO with 09 they have to pay a single zone postal charge and when shipped to an APO with a 96 zip code must pay for multiple zone charges. As an example, a 25 pound 2 cubic foot package from a Connecticut zip like 06033 to an APO 09xxx zip code would be \$13.82 and a zone 1. The same 25 pound package shipped to an APO 96xxx zip would be\$29.88 and a zone 8, and

WHEREAS a soldier's address is based on where they are shipping out from. A soldier from Ft. Dix in New Jersey will have the 09 zip. A Marine from Camp Pendleton in California will have the 96 zip, and

WHEREAS families and groups who support our Soldiers have the financial cost of shipping items and if the soldier is from theopposite coast the cost of postage may be more than the value of the items shipped.

THEREFORE BE IT RESOLVED that all APO and FPO addresses shall cost the one zone charge only. This will allow someone from several zones away from New York or California to support their soldier, Marine, or seaman and not spend extra money on postage and to be able to send more and larger items, and

BE IT FURTHER RESOLVED this removal of the added burden of expensive postage will aid the well-being of the U.S. Military and their families and friends.

THEREFORE BE IT RESOLVED that the Connecticut State Grange Board of Directors allocate funds, and hire a non-profit attorney to prepare and file the paperwork necessary in obtaining 501(c)(3) designation.

THEREFORE BE IT RESOLVED that Article IV, Section 7 of the CT State Grange By-Laws be changed to read: "Mileage will be paid at a rate to be determined by the Board of Directors of the CT State Grange for one round trip per Grange."

WHEREAS this provision does not allow for Deputies to be reimbursed for official visits beyond one inspection per year, and WHEREAS most Deputies do not even submit for the five dollar

per diem allowance.

THEREFORE BE IT RESOLVED that Article X, Section 2 of the Connecticut State Grange By-Laws be changed to read: "for such service shall receive mileage expenses for all official Grange visits as determined by the State Master, provided a satisfactory report is made to the State Master."

26. RE: NET NEUTRALITY

WHEREAS the National Grange has taken a strong stand on the issue of Broadband Regulation and recently issued a press release stating, "we want to see the FCC and concerned stake-

holders build a solid foundation for a strong and open internet. We support this process and hope that the commission will consider the needs of rural Americans as it seeks additional public comment," and

WHEREAS communications giants Google and Verizon recently issued a proposal to policymakers for keeping the internet open, and WHEREAS this proposal creates even greater concern for the future of a "strong and open internet" as their proposal gives the FCC the power to regulate broadband access, but gives the FCC no say regarding content, setting up a situation where companies like Verizon can supress content and essentially prevent upstart companies from developing tomorrow's Google or ebay, and

WHEREAS Google and Verizon's policy statement only applies to wireline networks and not wireless networks with the exception of one section providing for transparency when a provider like Verizon chooses to block content from a particular source, and

WHEREAS the largest growing segment of internet communication is through wireless technology, creating a tremendous area for exploitation for these companies if left out of a net neutrality agreement.

THEREFORE BE IT RESOLVED that the Connecticut State Grange urge the National Grange to add wireless networks to its legislative policy concerning Broadband Regulation to ensure all Americans will have a free and open internet regardless of the network they use, and

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to the National Grange for favorable action thereon.

27. RE: DEBIT CARD FEES

WHEREAS fees for using debit cards are becoming more common as financial institutions search for ways to make additional profits with increased federal regulation of credit cards, and

WHEREAS the use of debit cards has become as prevalent as the use of cash for routine purchases for millions of Americans every day, and

WHEREAS some states require financial institutions and credit card processing companies to notify consumers with an on-screen notice, much like those used at ATM's stating the amount of the charge and a request for approval of that charge, and

WHEREAS credit charges are not subject to these fees. THEREFORE BE IT RESOLVED that the Connecticut State Grange

urge the Connecticut Legislature to pass regulations requiring all financial institutions and credit card processing companies operating in this state to notify consumers of the debit card fee (if any) at the point of purchase and also explain the option of using the "credit" option to avoid these charges, and

BE IT FURTHER RESOLVED that the National Grange advocate for Federal regulations requiring all financial institutions and credit card processing companies nationwide to notify consumers of the debit card fee (if any) at the point of purchase and also explain the option of using the "credit" option to avoid these charges.

28. RE: OUTDOOR WOOD BURNING FURNACES

WHEREAS wood is a renewable resource of fuel, and

WHEREAS wood burning is used in agricultural productions such as greenhouses, heating water and buildings on dairy farms as well as residential homes, and

WHEREAS EPA regulations state that installation of outside furnaces must be at least 200 feet from the nearest home not heated by the furnace and the chimney on the furnace must be as tall as the roof peak of homes located within 500 ft. of the home not heated by the furnace, and

WHEREAS the General Assembly's Environment Committee has proposed to ban or limit the use of outdoor furnaces the last two previous years, and defeated in committee an act adding wood smoke to the Public Health nuisance code, and

WHEREAS Connecticut State regulations governing the use of wood-fired outside furnaces has been introduced and we anticipate it will be introduced in 2011.

THEREFORE BE IT RESOLVED that the Connecticut State Grange be opposed to local banning or limiting the use of outdoor wood furnaces, and

BE IT FURTHER RESOLVED since wood smoke emissions seem to be the major problem and manufacturers of wood stoves, wood furnaces, and outdoor wood furnaces are continually improving their products such as Gasification in wood burning to reduce smoke

emissions, and
BE IT FURTHER RESOLVED that the Connecticut State Grange oppose any new wood burning regulations on any wood burning as there are already regulations that address this issue as exampled by Burning regulations, and

BE IT FINALLY RESOLVED the Connecticut State Grange instructs the Legislative Committee to inform the members of the Connecticut Legislature of the Grange's opposition.

32. RE: LABELING FOR GLUTEN SENSITIVITY IN FOODS AND OTHER PRODUCTS SUCH AS MEDICATION

WHEREAS Celiac disease or gluten sensitivity can begin at any age, and

WHEREAS gluten is a protein found in many foods, including wheat, barley, and rye, and

WHEREAS gluten is also found in herbal supplements, some candies, cold cuts, white vinegar, malt flavoring, lip balms, and used as a "filler" in many other products such as vitamins, medications and stamp and envelope adhesive, and

WHEREAS the signs and symptoms of Celiac disease or gluten sensitivity can vary from few or mild symptoms to many and severe symptoms, including mal-absorption and malnutrition, fatigue, headaches, leg cramps, chronic abdominal pain, diarrhea, anemia, osteoporosis, peripheral neuropathy, and irritability and changes in behavior, and

WHEREAS as many as 1 in 133 people in this country are estimated to have gluten sensitivity, and

WHEREAS loss of productivity in the workplace can be a direct result when a person with gluten sensitivity ingests a gluten product, and

WHEREAS the only regulation in place regarding labeling products are gluten-free is only a voluntary regulation in the food industry and not currently applicable to other products such as medications, and

WHEREAS the gluten-sensitive person spends an inordinate amount of time researching online and/or reading the fine print on the labels, and

WHEREAS said labels may OR MAY NOT have the necessary information since current legislation is only voluntary, and WHEREAS even the pharmacists often do not know the complete

ingredients in the medications requiring them to contact the manufacturers when gluten sensitivity is an issue for a patient, and WHEREAS generic medications especially can differ from one manufacturer to another, and even from batch to batch within the

manufacturer in regard to their gluten content, and

WHEREAS even when ingredients are listed for a product, gluten may be disguised as wheat, durum, graham, kamut, semolina, spelt, triticale, barley, malt, malt vinegar, malt flavoring, rye, and modified food starch, thus requiring the inquiring mind to investigate all possibilities and read the fine print closely, and

WHEREAS the cost to the gluten-sensitive person can be very high in terms of real dollars lost when foods and medications containing gluten are purchased for use and then discontinued once the gluten is discovered, and

WHEREAS the cost to the health industry and the consumer is increased when the gluten-sensitive person is unable to properly absorb his/her medications resulting in the need for continually higher doses and more expensive brands, and

WHEREAS even a minute amount of gluten can present serious problems, and

WHEREAS regulations have been put in place for those sensitive to soy, nuts, and milk products used within foods REQUIRING appropriate labeling, and

WHREAS legislation proposed in 2009 to define "gluten-free" is still only in draft stages.

THÉREFORE BE IT RESOLVED that the Connecticut State Grange promote state and national legislation to REQUIRE clear labeling of food AND medicines as well as other products that may be ingested when they contain gluten in any form, or as gluten-free when they do not.
